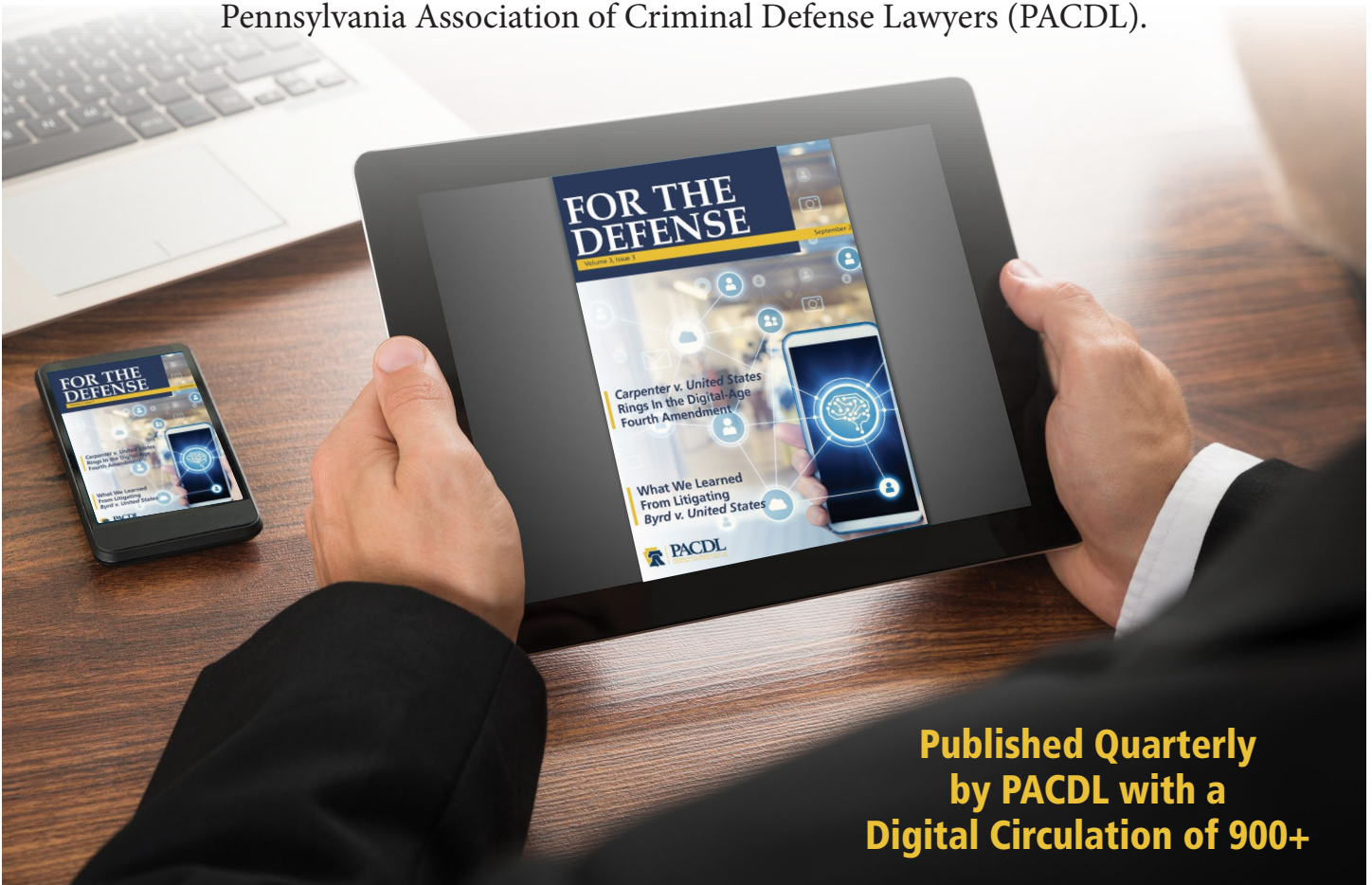

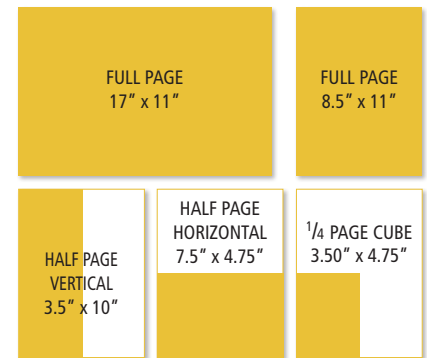

PLEASE READ CAREFULLY

The following terms and conditions are deemed to be a part of and incorporated in this agreement between PACDL and the advertiser and/or the advertising agency. The advertiser has read and agrees to abide by the current PACDL **For the Defense** Advertising Rates and Terms and Conditions for publication of a digital advertisement as set forth in this contract.

- 1. Editorial and Advertising Policy:** The acceptance of digital advertising in this publication does not necessarily constitute an endorsement by the Pennsylvania Association of Criminal Defense Lawyers for products and services offered by the advertisers. Official positions and services endorsed by the Pennsylvania Association of Criminal Defense Lawyers will be clearly stated and noted in this digital publication. Opinions by authors do not necessarily reflect positions of PACDL. The association reserves the right to reject any advertisement deemed inappropriate for publication in **For the Defense**.
- 2. Advertising payments:** Advertisers must pay no later than 20 days in advance of the publication date. All legal obligations arising out of the placement of the advertisements will be binding on both the company and advertising agency. The company and advertising agency each agree to be jointly and severally liable for the payment of all bills and charges incurred for each ad placed on the company's behalf. If submitting advertising for the first time and the closing date has passed, PACDL will charge a 15 percent (15%) late penalty if it is still able to accept and timely process the new advertisement.
- 3. Advertising Author's Corrections:** All author's corrections on advertisement copy shall be billed as an additional charge to the advertiser or ad agency. No cancellations or ad copy changes will be accepted after the closing date.
- 4. Contract Regulations:** PACDL reserves the right to reject any advertisement for reasons including: the advertisement, whether through its grammar, layout, artwork or otherwise, fails to meet editorial standards of the publication; the advertisement advertises or otherwise promotes a product that PACDL, as a matter of practice or policy, has decided not to advertise; the advertisement makes untrue or misleading claims or otherwise disparages a competing product; or the advertisement is in poor taste.
