## Introduction

PACDL is selective in the cases to which it lends its support as amicus curiae. The Amicus Committee recommends filing amicus curiae briefs to the PACDL Board of Directors only in carefully selected cases that present issues of extraordinary importance to criminal defense lawyers and the criminal defense system and where PACDL can make a meaningful and original contribution. PACDL prioritizes support in instances where the appeal has reached the highest level of review. In appropriate circumstances, the Amicus Committee may consider and recommend support for an important case at a different level of review before a state or federal court.
